COVERAGE PROVIDED BY THE ANNUAL COPYRIGHT LICENSE

Photocopy articles and portions of other works for an employee's own internal business use and/or to share with co-workers.

Download and print portions of electronic works.

Scan paper copies of works (when an electronic version is not available).

Distribute electronic copies of works internally, via intranet posting, email or collaboration applications such as Lotus Notes.

Share a single electronic copy of an article with a client for one time use.

Distribute paper copies internally.

Attach copies of articles to internal company communications such as newsletters, training materials and presentations.

Set up storage files of electronic works as part of company work product to maintain permanent electronic records.

Submit electronic filings to government agencies for regulatory purposes.
