Request Article Reprints/ePrints

Marketplace: Request Article Reprints/ePrints

Request a quote for article or chapter Reprints and ePrints from Marketplace using these instructions. Once you submit a request form, CCC's Reprints Team reviews the request details and generates a quote for your review and approval, prior to the fulfilment of the request.

Please note: Reprints/ePrints quotes are available at the article/chapter level only, not at the publication level.

1. Search for the Article/Chapter

- Go to http://marketplace.copyright.com
- In the search bar, enter the Title/Author/Keywords/PMID/ISSN/etc. for the article/chapter and click on Search
- Marketplace returns matches to your search, which may include publication and article or chapter matches. Review the search results to locate the article/chapter you need.
- Too many search results? Use the filters at the left to limit the results by Publication Type, Language, or Country.
- If the article/chapter/publication record includes the *Reprints/ePrints* option, click on it to open a request form.

2. Complete the Reprints/ePrints Request Form

- Enter your contact information at the top of the form.
- From the drop-down, select either Reprints (physical copies of the article) or ePrints (digital copies of the article).
- Specify if you want Reprints shrinkwrapped by selecting the "Yes" or "No" radio button.
- Enter citation information for the specific article in the fields "Article Title" through "Pages".
- Type the quantity of Reprints/ e-Prints for which you want a quote.
- Click on Submit Request



3. Order Confirmation and Quotes

- You will receive a confirmation message on the screen and a confirming email to the e-mail address you provided.
- The CCC Reprints Team will research your request and provide a quote. Once you approve the quote, the Reprints/ePrints will be fulfilled.
