# WHAT'S NEW WITH RIGHTSLINK FOR PERMISSIONS?

#### **February 2023 Release**

The focus of the February release is to:

- 1. Provide an enhancement for **Managing Special Requests** to retain assignee unless there are specific rules in place for your account.
- 2. Improve your ability to **manage requests for high-resolution images** in a more automated fashion.
- 3. **Enhance the account registration workflow** through clarification of messaging, help text, and navigation.
- 4. **Perform required technical upgrades** to ensure platform stability with latest upgrades and data.

#### **Retention of Assignee for Updated Special Requests**

With the February release, we have made an enhancement to retain the assignee on special requests unless there are specific rules determining staff assignments based on the type of request. If an update is made to a request post-February release, the original assignment is enforced. This allows staff to continue to easily view the requests for which they are responsible.

## Improvements for Managing Requests for High-Resolution Images

We will introduce two improvements for publishers who offer permissions and delivery of high-resolution images to take advantage of post-release:

- 1. The ability to receive an e-mail notification when a customer places an order for a hiresolution image through RightsLink for Permissions. Today this is a manual notification process and delays can occur for time-sensitive requests.
- 2. The ability to filter reports for high-resolution images so transactions are visible at a glance in RightsLink for Permissions PubAdmin. For publishers not offering this permission and content through their configuration of RightsLink for Permissions the filter is not visible.

#### **Enhancements to Account Registration Workflow**

Recently CCC made updates to the RightsLink for Permissions account registration workflow to enhance the security of our system. When new customers register for an account, they receive a numeric code via email which they are required to input to complete the registration process. Subsequently, we have made some improvements around messaging to help guide them through the process. Clarification of messaging on the input box and links to our customer knowledge base allow them to self-serve answers to the questions they may have.
