As part of the new Home page, we've also updated the top navigation. We updated the order of items and reduced the amount of text in the navigation. Note, all the options remain the same.

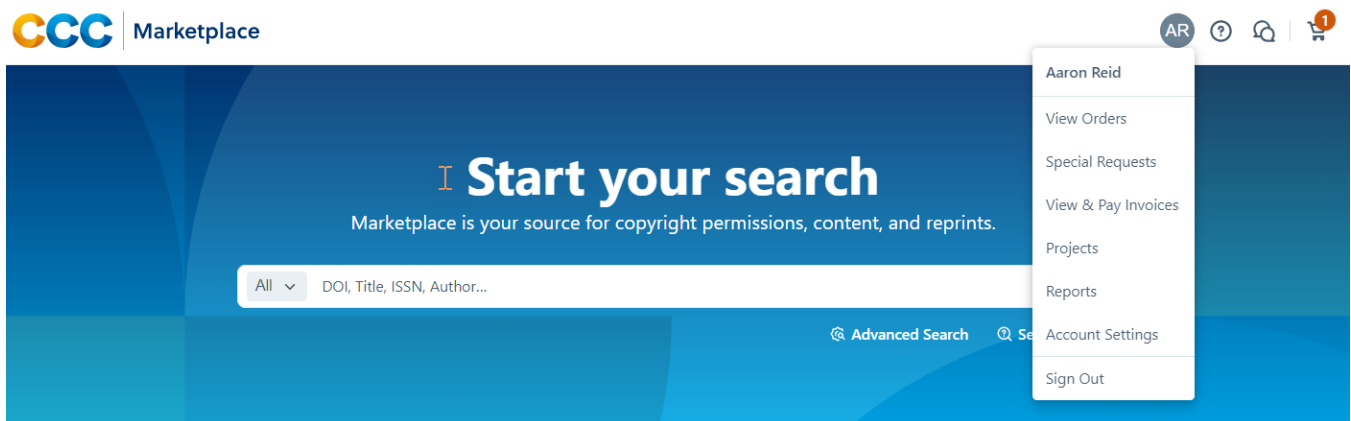
Old Navigation:



New Navigation:




Logged-in view:
