RightsLink users in Canada can now enter their Canadian and Provincial Tax IDs and include this information in their order details. New users can enter a Canadian Tax IDs when registering and returning Canadian users are prompted to enter their tax details or opt out as shown below.



Canadian Tax IDs are captured as part of purchased licenses and appear in the workflow.

This improved workflow makes it easier for customers to review and verify their order prior to submission.
